THE PROOF AS TO WAR CRIMES AND CRIMES AGAINST HUMANITY

Judged by any standard of proof the record clearly shows the commission of war crimes and crimes against humanity substantially as alleged in counts two and three of the indictment. Beginning with the outbreak of World War II criminal medical experiments on non-German nationals, both prisoners of war and civilians, including Jews and "asocial" persons, were carried out on a large scale in Germany and the occupied countries. These experiments were not the isolated and casual acts of individual doctors and scientists working solely on their own responsibility. but were the product of coordinated policy-making and planning at high governmental, military, and Nazi Party levels, conducted as an integral part of the total war effort. They were ordered, sanctioned, permitted, or approved by persons in positions of authority who under all principles of law were under the duty to know about these things and to take steps to terminate or prevent them.

PERMISSIBLE MEDICAL EXPERIMENTS

The great weight of the evidence before us is to the effect that certain types of medical experiments on human beings, when kept within reasonably well-defined bounds, conform to the ethics of the medical profession generally. The protagonists of the practice of human experimentation justify their views on the basis that such experiments yield results for the good of society that are unprocurable by other methods or means of study. All agree, however, that certain basic principles must be observed in order to satisfy moral, ethical and legal concepts:

1. The voluntary consent of the human subject is absolutely essential.

This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.

The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.

3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results will justify the performance of the experiment.

4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.

5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.

 The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.

 Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability, or death.

8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probably cause to believe, in the exercise of the good faith. Freedom of choice is a founding principle in Democracy, and there can be no more fundamental and utterly critical critical freedom of choice than that which directly affects one's very own body. Following the Nuremberg trials in Germany after World War II, this fundamental human right was resoundingly underscored in what later became the legally adopted Nuremberg Code (by allied countries, including the US).

The informed consent principle was defined as a human right at the Doctors Trial at Nuremberg in 1947. The Nuremberg Code was, in fact, written by two Americans in 1947. It was designed to totally prevent and forever avoid forced medicine in any form, including vaccines [this was in response to horrific experiments and forced vaccination performed on unwilling subjects during World War II in concentration camps].

The first principle in the Nuremberg Code is as follows:

"The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved, as to enable him to make an understanding and enlightened decision." The following well referenced, highly eloquent and relevant section was written by Barbara Loe Fisher of the National Vaccine Information Center:

Informed Consent means you have the right to be fully informed about the benefits and risks of a medical intervention and the freedom to make a voluntary decision about whether or not to accept those risks without being coerced or punished for the decision you make. Informed consent applies not just to risks taken by participants in scientific experiments, but also to risks taken by patients under the care of physicians.^{2,3,6,5}

Council of Europe: No compulsory vaccinations and no discrimination against the unvaccinated

On 27 January, the Council of Europe signed Resolution 2361, which states that vaccinations in EU Member States should not be mandatory. Furthermore, persons who have not been vaccinated may not be discriminated against in any way. This effectively stops the notion of "vaccine passports".

The resolution goes so far as to order member states such as Sweden to actively inform citizens of these rights. The resolution has been ignored by mainstream politicians and the media.

Many citizens have been worried about whether the untested vaccines will be mandatory, since it has already been proposed in several countries. In Sweden, however, it has not been, because of a law which prohibits involuntary medical interventions. But despite this law, governments could exert such strong pressure on their populations, that it could become almost impossible to live without being exposed to this experimental jab.

Happily, the Council of Europe is now putting a firm stop to these plans, since involuntary medical experiments are prohibited by the Nuremberg Convention.






